6. All terms and conditions of the standard form rental ticket of Renard Lakes Holding, L.L.C. shall additionally apply to any extension of credit to applicant.

In the event of non-payment by applicant of any invoice, applicant hereby irrevocably assigns to Renard Lakes Holding, L.L.C. any progress or other payments due to applicant for work done by applicant on the construction project to where the invoice relates, to the extent said assignment is necessary to pay said invoice. Provision of a copy of this credit agreement with a copy of the unpaid invoice shall constitute full and complete authority and direction by the applicant for any funds so due to the applicant to be paid directly to Renard Lakes Holding, L.L.C., in satisfaction of the unpaid invoices.
